

Terms and Conditions of Use

1. Acceptance of Terms

- By accessing or using the Tecniplast SpA (“Tecniplast”) platform powered by Skipso (the “Platform”), you agree to be bound by these Terms and Conditions of Use (“Terms”).
- If you do not agree to these Terms, you may not access or use the Platform.

2. Description of Platform

The Platform provides a space for users to submit and review ideas, projects, and needs for the purpose of bringing innovation and identify opportunities for future potential project to enhance processes efficiency, automation and other opportunities.

3. User Accounts

- You may be required to create an account to access certain features of the Platform.
- You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account.
- You agree to provide accurate, current, and complete information during the registration process and to update such information to keep it accurate, current, and complete.

4. User Content – Representation and Warranties

- You are solely responsible for any content, including ideas, projects, startup information, and other materials (“User Content”), that you submit or otherwise make available through the Platform.
- By submitting User Content, you grant Tecniplast and its affiliates a non-exclusive, worldwide, royalty-free license to use, reproduce, modify, adapt, publish, translate, distribute, and display such User Content for the purpose of operating and providing the Platform's services.
- You represent and warrant that you have all necessary rights to grant the licenses set forth in these Terms and that your User Content does not violate any third-party rights or applicable laws.
- The Participant shall refrain from obtaining, or trying to obtain, any IP Right.
- You shall indemnify and hold harmless the Organizer for any allegations or claims by third parties in case of infringement of Third Parties’ Intellectual Property Rights by their Proposals.
- You represent and warrant that your content does not include information or content that is false, fraudulent, defamatory, obscene, hateful, unlawful, or injurious to any individual.
- All information, documentation, and data resources put directly or indirectly at your disposal by Tecniplast shall be treated with confidentiality and shall not be disseminated in any way to third parties by you, nor commercially exploited.

5. Acceptable Use

- You agree to use the Platform only for lawful purposes and in a manner that does not violate these Terms or any applicable laws or regulations.
- You agree not to:
 - Use the Platform in any way that could damage, disable, overburden, or impair the Platform.
 - Attempt to gain unauthorized access to the Platform or any accounts, computer systems, or networks associated with the Platform.
 - Impersonate any person or entity or falsely state or misrepresent your affiliation with any person or entity.
 - Use any robot, spider, scraper, or other automated means to access the Platform for any purpose without our express written permission.
 - Introduce any viruses, worms, or other malicious software code to the Platform.

6. Intellectual Property Rights

- The Platform and any content made available on or through it, including but not limited to text, graphics, logos, software, designs, databases, documentation, materials, and functionalities, are and shall remain the exclusive property of Tecniplast or its licensors and are protected by applicable intellectual property laws.

- By submitting or developing any such content on the Platform, you irrevocably assign, transfer, and convey to Tecniplast, without additional compensation, all rights, title, and interest therein, including any and all intellectual property rights, whether existing now or arising in the future, on a worldwide basis and for the full duration of such rights. Tecniplast shall have the unrestricted right to use, reproduce, modify, adapt, publish, translate, distribute, commercialize, exploit, and otherwise make use of such content for any purpose.
- You further agree to execute any documents and take any actions reasonably requested by Tecniplast to confirm, perfect, or enforce such ownership rights. To the extent any such rights cannot be assigned under applicable law, you grant Tecniplast an exclusive, irrevocable, perpetual, worldwide, royalty-free, transferable, and sublicensable license to fully use and exploit them permitted by law.
- You represent and warrant that you have all necessary rights and authority to submit such content and to assign or license the related rights to Tecniplast as set out in these Terms.
- You may not modify, reproduce, distribute, create derivative works of, publicly display, or in any way exploit the Platform or its content, in whole or in part, except as expressly permitted by Tecniplast.

7. Third-Party Links

- The Platform may contain links to third-party websites or resources.
- Tecniplast is not responsible for the content, products, or services on or available from those websites or resources.
- You acknowledge and agree that Tecniplast is not liable for any loss or damage which may be incurred by you as a result of the availability of those external sites or resources, or as a result of any reliance placed by you on the completeness, accuracy, or existence of any content, advertising, products, or other materials on, or available from, such websites or resources.

8. Disclaimer of Warranties

- The Platform is provided on an "as is" and "as available" basis.
- Tecniplast disclaims all warranties, express or implied, including but not limited to implied warranties of merchantability, fitness for a particular purpose, and non-infringement.
- Tecniplast does not guarantee that the Platform will be uninterrupted, error-free, or secure, or that all defects will be corrected.

9. Limitation of Liability

To the maximum extent permitted by applicable law, Tecniplast shall not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits or revenues, whether incurred directly or indirectly, or any loss of data, use, goodwill, or other intangible losses, resulting from (a) your use or inability to use the Platform; (b) any unauthorized access to or use of our servers and/or any personal information stored therein; (c) any interruption or cessation of transmission to or from the Platform; (d) any bugs, viruses, Trojan horses, or the like that may be transmitted to or through the Platform by any third party; (e) any errors or omissions in any content or for any loss or damage of any kind incurred as a result of your use of any content posted, emailed, transmitted, or otherwise made available through the Platform.

10. Governing Law and Dispute Resolution

- These Terms shall be governed by and construed in accordance with the laws of Italy.
- Any dispute arising out of or relating to these Terms shall be resolved by the exclusive jurisdiction of the Courts of Milan, Italy.



10. Termination

- Tecniplast may terminate your access to the Platform at any time for any reason, with or without notice.
- You may terminate your account at any time by visiting the “manage account” section of the platform in the top-right user menu when you login.

1. Severability

If any provision of these Terms is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall remain in full force and effect.

1. Entire Agreement

These Terms constitute the entire agreement between you and Tecniplast relating to your use of the Platform and supersede all prior or contemporaneous communications and proposals, whether oral or written, between you and Tecniplast.
